

## “ Super Green Online Contest ”

### Official Rules

March, 2014

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

2. CONTEST RULES MAY BE CHANGED AND POSTED AT [WWW.LIVEGREENSLC.COM](http://WWW.LIVEGREENSLC.COM) FROM TIME TO TIME. IT IS THE RESPONSIBILITY OF THE ENTRANT TO REGULARLY CHECK CURRENT CONTEST RULES. The rules posted at [www.LIVEGREENSLC.com](http://www.LIVEGREENSLC.com) supersede all other previously published rules.

3. **Eligibility Restrictions.** To participate in the 2014 Annual Live Green SLC! Festival Super Green Online Contest (the "Contest"), entrants must be at least 18 years old and a resident of the state of Utah at the time of entry. A valid driver's license or other form of acceptable photographic I.D. as well as knowledge of entered email address will be required to claim prize. (Email addresses required to help verify winner if similar names dispute occurs, no volunteering or email list opt-in is required.)

4. **Contest Period.** Contest period begins on March 27, 2014 at 12:01 AM Mountain Time and ends on May 02, 2014 at 11:59 AM Mountain Time when list of entrants will be closed to additional names.

1. **Entrants must first complete an entry form** found on [WWW.LIVEGREENSLC.COM](http://WWW.LIVEGREENSLC.COM) completely with valid name, valid email address, as well as name of a valid business found in ReDirect Guide's print or online editions;
2. **Then Entrants must check in at ReDirect Guide's Event Booth** (*located at approximately 440S 200E in Salt Lake City Utah*) **between 11:00 AM and 4:00 PM (Mountain Time), Saturday, May 03, 2014** to determine if their name is selected as winner in a random process.
